### Spring Cleaning . . .

Spring is just around the corner, and what a better way to prepare for its arrival than do some good old spring cleaning!

In our most recent walkthrough of the stable, we have noticed a lot of items being stored in front, next to, or in adjacent stalls. Also, there's seems to be quite a bit of "storage" around the tack sheds.

As a reminder, you are allowed the following items only in front of your stall. Here are the "deets" on the allowable items:

**1) Feed Box:** The feed box must be placed in front of your stall only. Not next to, in the empty stall next door, at the end of the barn, etc.

Each stall is allowed one feed box per stall and must be maintained in good working condition

The feed box dimensions can not exceed any of the following dimensions:

- Height : 30"
- Width: 60"
- Depth: 18"
- Volume: 18 cubic feet

To assist you in selecting a box, the following are some of the allowable models:

- Rubbermaid: 3753, 5E39, 5F21
- Lifetime: 60012, 60059

**2) Metal Trash Can:** A single metal trash can, not exceed 31 gallons, can also be placed in front your stall.

**3) Muck Bucket:** A part of our new water quality rules, each stall is required to have a



manure bucket in front of the stall.

**4) Rakes:** A maximum of two types of rakes can be stored in front of your stall.

**5) Other Storage Conditions:** Hay and feed deliveries must be put away either in the feed box, trash can, or tack shed within 24 hours of delivery. Shavings must be either stored in tack shed or spread within 48 hours. Empty stalls, in and around tack sheds, etc. are not allowable storage areas.

We understand that this will take some effort, so please harmonize your area by April 15th
